2018 Participation fees are at a low cost and range from \$500 to \$3250.

3 The Historical Data Uploader (HDU)
This feature is available for a limited time for sites to have historic ACTION Registry-GWTG data uploaded into GWTG-CAD.

4 Data Source for Mission: Lifeline STEMI Accreditation
GWTG-CAD is a data platform accepted for accredited STEMI Receiving Centers and STEMI Referring Centers.

5 Individual Support
GWTG-CAD participation includes local, complementary face-to-face or virtual one-on-one Quality & Systems Improvement support to participating hospitals.

6 Educational Offerings
GWTG-CAD participants may take advantage of complimentary educational offerings.

7 Mission: Lifeline Recognition
GWTG-CAD is the official data platform for the AHA's Mission: Lifeline hospital recognition program. Recognized hospitals may promote their AHA recognition status, are listed in US News & World Report and are honored at AHA Scientific Sessions.
