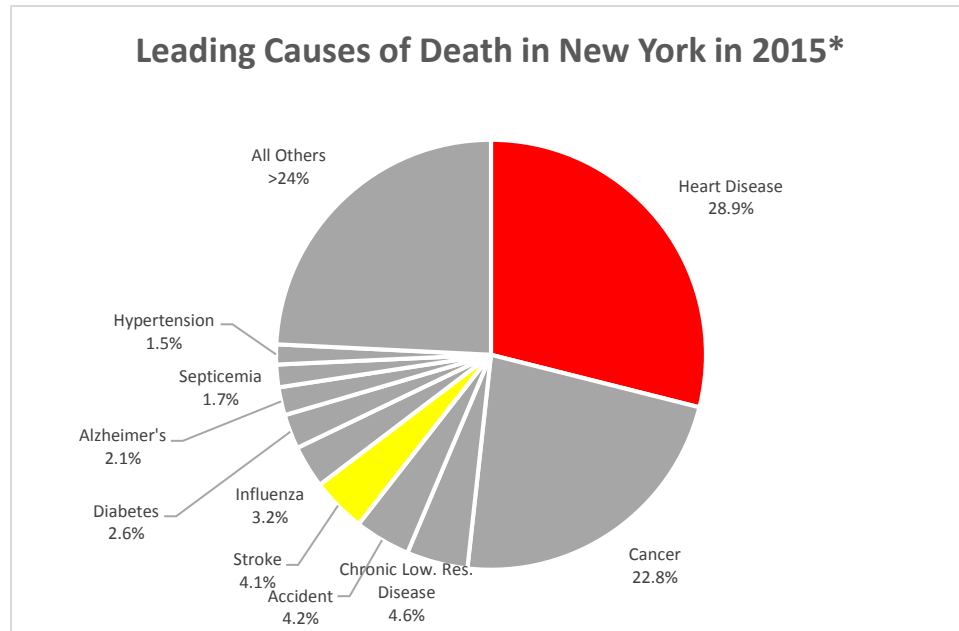


New York Fact Sheet



New York has the 19th highest death rate from cardiovascular disease in the country.**

- Heart disease is the no. 1 killer in New York*
- 44,450 people in New York died of heart disease in 2015*
- Stroke is the no. 5 killer in New York*
- 6,292 in New York died of stroke in 2015*
