What is **Public Health?**

Public health is the science of protecting and improving the health of families and communities through promotion of healthy lifestyles, research for disease and injury prevention, and detection and control of infectious diseases.

Why We Need a Stroke System of Care



- One of the leading cause of death & disability nationwide
- Time-critical care significantly impacts outcomes
- Rural geography creates access and coordination challenges
- Current care is not standardized across facilities
- A system ensures consistent protocols, rapid response, & quality improvement
- Builds on the proven success of our trauma system

South Dakota's Trauma System: A Proven Model

- Created in 2008 with the 3 large healthcare systems
- System of Care
- Standardized Protocols & Standardized Care
- Statewide Trauma Registry
- Statewide Performance Improvement
- Annual Trauma Meeting and Training

South Dakota + AHA: Advancing Stroke Care Together



- \$5M+ stroke via Mission: Lifeline Stroke (October 2024)
 - Supported by the Helmsley Charitable Trust
- Post-Acute Stroke Initiative
 - Recruiting skilled nursing, rehab, and critical access hospitals
- Statewide Data Standardization in Progress
 - Moving from siloed hospital data to a unified stroke registry
- Alignment with National Standards
 - Several SD hospitals already recognized under Get with the Guidelines ®
