The STEMI Referring form is designed to serve the specific needs of Referring hospitals. This form provides minimal STEMI data collection while still granting access to real-time advanced analytics and reports, including the Mission: Lifeline Regional reports and recognition.

## Mission: Lifeline Feedback Reports

This report allows for the generation of Patient Feedback Reports that summarize selected date/times, calculated time differences, and other noted data points. These reports can be used to provide feedback to entities like EMS partners.
