- Anticipate FMC-to-Device in < 90 minutes Tx by: Air Ground
- Anticipate FMC-to-Device in < 120 minutes: Tx by: Air Ground
- Anticipate FMC-to-Device via transfer > 120 minutes: Tx by: Air Ground evaluate for Lytics (Door-to-Needle ≤ 30 minutes)
